Review Dementia State Plan Draft Goals 6 (Brain Health and Dementia Risk Reduction)

Mr. Worthington provided some context for the workgroup about the BOLD Infrastructure Act, and Virginia adopted the same language into the Code of Virginia to direct VDH to incorporate brain health and dementia risk reduction messaging. He also provided the background on the BOLD grant project including the collaboration with the Brain Health Coordinator at VDH. Mr. Worthington then described the Healthy Brain Initiative and talked about how it has been interwoven throughout the Dementia State Plan. He then walked through the Draft Goal 6 of the Dementia State Plan. The Dementia State Plan will be reviewed by the Commission on December 12. Members

Ms. Heyn suggested partnering with colleges and universities to leverage student volunteers to offer things like community screenings or education. Ms. Coney mentioned the Youth Advisory team and the collaboration between VDH and historically black colleges and universities. Mr. Worthington mentioned the YMAA Youth Movement Against Alzheimer's and the nursing students at EVMS who are supporting Dementia Friends. Members also mentioned potentially working with fraternities and sororities.
