Discussion: 2024 Activities

Mr. Worthington briefly reviewed developments regarding the implementation plan and the next steps for its formal adoption in September.

Workgroup members were asked before the session to rank their first three choices from among the strategies contained in the implementation plan, and from among those that were not included in the implementation plan.

The first strategy discussed was the Dementia Care Practitioner recommendation. Members discussed who this should be aimed at and that should include home health care, long-term care alternatives, long-term care staff, healthcare and behavioral health, faith communities, other ancillary staff (AAAs/CSBs). Mr. Worthington will develop a draft one-pager on the trainings for consideration by the workgroup at its next meeting.

Next the group discussed the strategy addressing linking paid and unpaid caregivers with information about dementia and the caregiving process. Mr. Worthington noted that this would be ongoing and there would be information planned for Dementia Capable Virginia that this group could review and provide input on.

Discussion continued on training for emergency services personnel incorporating the changes to the legislation this year. There were several ideas for connecting people to free trainings offered by the Alzheimer's Association and others.

Members discussed ways of reaching Medicaid care coordinators and Ms. Napper noted that the monthly training call continues through DMAS.

Members discussed dementia specific advance directives, and will review several alternatives before the November meeting. Mr. Worthington reviewed the Best Practice Caregiving website in the context of supporting training programs for unpaid caregivers. Members will review these programs gradually with a view to selecting several to comprise a suite of offerings for a comprehensive dementia-capable training.
