#### **Legislative Update**

Heather Kidd shared that although the General Assembly is not in session, several key policy priorities are being proposed for next year. The Alzheimer's Disease and Related Disorders (ADRD) Commission's proposals include funding 25 dementia care navigators, one at each Area Agency on Aging, renewing the Commission beyond its 2025 sunset, expanding dementia training

for first responders, restoring respite voucher funding, and creating a caregiver tax credit.

The Commonwealth Council on Aging supports the ADRD Commission's renewal and is requesting funding for the Virginia Memory Project.

### Updates

**Dementia Care Coordination Roundtable:** Ms. Kidd gave an update on the July 28 Roundtable and announced the next meeting is September 22, 2025.

**Dementia Road Map:** Ms. Kidd shared that staff received the updated 2025 Road Map a few weeks ago, with 1,200 copies distributed already and the updated version available on the DCV website since early May. She encouraged members to request maps and share this resource with others

### Discussion

**Plans for Morning Summit:** Ms. Kidd reported that the Alzheimer's Commission will host a Dementia Summit on the morning of September 9 at the Virginia Hospital & Healthcare Association in Innsbrook, Richmond. The event, open to all workgroup members, will engage legislators and key stakeholders through three sessions covering Virginia's current dementia landscape, the costs of inaction, and opportunities for improvement. Presentations and panel discussions will include perspectives from those with lived experience, and the summit will conclude with lunch provided.

**Implementation Plan/Dashboard:** The group reviewed progress on Dementia State Plan strategies and Dementia Capable Virginia (DCV) website updates. Ms. Kidd shared the dashboard is live; members suggested making it more prominent and adding the last updated date with a note on quarterly updates.

**Assisted Living Facility (ALF) recommendations:** The group briefly discussed the topic and plans to revisit this topic at the November meeting.
