<p>Virginia Department of Health (VDH) Building our Largest Dementia Infrastructure (BOLD) Report Rachel Coney Bowles provided a program summary and update on the progress of the BOLD plan's Healthy Brain Virginia (HBV) strategy accomplishments, focusing on the ADRD-related goals outlined in the BOLD Report:</p> <ul style="list-style-type: none"> • Strategy 5: Public Education Efforts included integration of HBV Community Programs with the Alzheimer's Association and establishing new partnerships with Southside Bon Secours, Crater District AAA, Crater Hospice, and VCU Medical Center's Trauma Injury & Violence Prevention Program. Five Virtual Dementia Training (VDT) sessions reached 55 participants, with 30 individuals trained, including sessions for Richmond Ombudsman, Dementia Care Navigators, Riverside College, and Central Virginia. • Strategy 6: Provider and Professional Education Ninety-one individuals received in-person training, comprising 31% EMTs, 25% Paramedics, and 41% other professionals. Training was conducted across multiple counties including Chesterfield, Hampton, Hanover, Henrico, Madison, Newport News, Prince George, Richmond City and County, and York. The BOLD PHCOE Early Detection Toolkit is currently being printed for health systems, alongside the development of rack cards featuring excerpts from the Dementia Road Map. 	
<p>Alzheimer's & Related Diseases Research Award Fund (ARDRAF) Update Faika Zanjani shared the 2025–2026 ARDRAF recipients, four projects funded to advance Alzheimer's research:</p> <ul style="list-style-type: none"> Shannon Farris, Ph.D., & Sharon Swanger, Ph.D., Virginia Tech: The role of dendritic mitochondria in synapse dysfunction Andrew A. George, Ph.D., Virginia Commonwealth University: Ionic and transcriptional mechanisms of amyloid-beta–induced neuronal instability Robert Ariel, Ph.D., Virginia Wesleyan University: Care partner–centered intervention to improve knowledge and wellbeing Elise Cope, Ph.D., University of Virginia: Perineuronal net contribution to social memory loss <p>Ms. Zanjani also noted that the 2026 ARDRAF funding opportunity will open soon. Four grants of \$75,000 will again be awarded. Letters of intent are due by December 1, 2025, full applications by February 1, 2026, award notifications by July 1, 2026, and the funding period runs from July 1, 2026, to June 30, 2027.</p> <p>A group member asked whether study outcomes could be tracked and added to the Implementation Plan dashboard. Staff confirmed that findings, once studies are complete, will be included along with any accompanying researcher-produced infographics.</p> <p>Please see the Press release as well as the Letter of Intent for the 2026 funding opportunity.</p> <p>Commission members noted the increased award amount and emphasized the importance of sharing the results with local communities, as well as highlighting these awards within their networks.</p> <p>A related discussion addressed community-focused messaging, with members asking what more the Commission could do in this area. <p>Workgroup Reports</p> <p>Coordinated Care Workgroup</p> <p>The Coordinated Care workgroup met on August 4, 2025 to discuss regulation reviews and other work related to achieving State Plan strategies that are included in the Implementation Plan. The group discussed the following updates:</p> <ul style="list-style-type: none">• ADRD Commission's 2025 legislative recommendations and related Commonwealth Council on Aging proposals.• The 2025 Dementia Road Map is available online and in print; members were encouraged to request and share copies.• Updates were provided on July 28 Dementia Care Coordination Roundtable, with the next meeting scheduled for September 22, 2025.• Dementia Morning Summit, Dementia State Plan progress, and the new Dementia Capable Virginia dashboard, providing feedback.• Assisted Living Facility recommendations, with plans to revisit in November to prepare a draft for the ADRD Commission. <p>Training Workgroup</p> <p>The Training workgroup met on August 5, 2025 to discuss priorities for the group to work on in the context of the Implementation Plan.</p> <ul style="list-style-type: none">• Mr. Worthington provided a legislative update on 2025 recommendations from the ADRD Commission and two from the Commonwealth Council on Aging.• He also updated the group on Dementia Morning Summit plans and the Dementia Capable website rebuild, which is on track for a January launch and praised for its clean design.• Rachel Coney-Bowles reported on the Healthy Brain Initiative's Community Health Worker Module: since May 2024, nearly 200 participants have completed free training, with 55 this quarter; 78% are CHWs, followed by outreach specialists, volunteers, apprentices, and care coordinators.• Alzheimer's Association members shared two new training programs: the Dementia Care Navigation Series and the individual Care Navigation ECHO, launching October 2025.• Mr. Worthington outlined Implementation Plan progress, including collecting external participation via an updated QR code form, advancing Goal 3 objectives (Dementia Friends reboot, policy recommendations), and exploring a caregiver podcast through a Geriatric Training and Education grant opportunity. <p>Brain Health Workgroup The Brain Health Workgroup met on July 17, 2025, to review brain health data and messaging materials, and to discuss upcoming activities and next steps.</p> <ul style="list-style-type: none"> Mr. Worthington shared a draft social media toolkit linking six brain health domains to AAA programs; members provided feedback. He also shared updated brain health flyers for co-branding and previewed Morning Summit plans. Staff introduced Hilarity for Charity's youth-focused brain health microlearning videos; members viewed one and suggested expanding education to places such as schools, libraries, and universities. Mr. Worthington noted the Dementia State Plan dashboard is live; members discussed strategies for reaching underserved groups and linking chronic disease to brain health. Rachel Coney-Bowles highlighted plans to expand Community Health Worker dementia training and partner with the Ombudsman program on VDT. Ms. Coney-Bowles outlined Year 3 HBV priorities: expand coalition engagement, offer culturally tailored education, strengthen community linkages, use data to guide outreach, promote dementia-informed policy, and increase visibility through campaigns and events. 	<p>George Worthington (for Michael Watson)</p>
<p>Data and Research Workgroup The Data and Research Workgroup met on August 5, 2025 to discuss the research section of the Dementia Capable Virginia website.</p> <ul style="list-style-type: none"> Heather Kidd provided a legislative update on the ADRD Commission's 2025 recommendations and two Commonwealth Council on Aging proposals related to dementia. Annie Rhodes shared an update on the StARS grant plan. The group reviewed plans for the Dementia Morning Summit. Members briefly reviewed an updated flyer promoting research participation. The group discussed the next steps for advancing Objective 5.2, focusing on expanding dementia research and translating findings into community-based care. Ideas included deploying research navigators through AAAs, with DARS as a central hub. Annie Rhodes and DARS staff will gather insights from other states. General Assembly 2025

HB1931 Regional Older Adults Facility Team (RAFT); central/eastern Virginia (LeVere Bolling, left in Appropriations)

Department of Behavioral Health and Developmental Services; community services boards; Regional Older Adults Facility Team; central and eastern Virginia. Directs community services boards located in Central and Eastern Virginia to establish a Regional Older Adults Facility Team to provide services to older adults with mental illness and dementia in each region modeled after the Regional Older Adults Facility Team program conducted by the Northern Virginia Regional Projects Office.

Budget Amendments (in enrolled budget)

315.Q Interdisciplinary Plan of Care and Dementia Case Management (DARS)

N. Out of this appropriation, \$400,000 from the general fund the second year shall be provided to the Capitol Area Agency on Aging [*The Span Center, Richmond*] and Local Office on Aging, Inc. [*Roanoke*] for an interdisciplinary plan of care and dementia case management for 200 individuals diagnosed with dementia. Funding shall be allocated evenly between the two Area Agencies on Aging. The Department for Aging and Rehabilitative Services shall report the status of the program and provide an update on the results of the dementia case management program to the Chairs of the House Appropriations and Senate Finance and Appropriations Committees by November 1 of each year.

United States 119th Congress (S=Senate, HR=House of Representatives)

- H.R.3389 Alzheimer's Law Enforcement Education Act of 2025. Would direct the Director of the Office of Community Oriented Policing Services of the Department of Justice to establish an online training course relating to ADRD. Referred to the House Committee on the Judiciary (5/14/2025).
- H.R.3501/S.1799 Amend Title XVIII of the Social Security Act related to cognitive screening at Medicare Annual Wellness Visit. Would require use of a validated instrument and documentation of instrument used in the Medicare Annual Wellness required cognitive screening. H: Referred to the Committee on Energy and Commerce and the Committee on Ways and Means (5/19/2025). S: Read twice and referred to the Committee on Finance (5/19/2025).
- H.R. 3674 Global Alzheimer's Initiative Now Act. Would permit the United States to participate in the Davos Alzheimer's Collaborative. H: Referred to the Committee on Foreign Affairs (6/3/2025).
- H.R. 3747AADAPT Act. Would amend the Public Health Service Act to reauthorize the Project ECHO Grant Program to establish grants under such program to disseminate knowledge and

build capacity to address ADRD. H: Referred to the House Committee on Energy and Commerce (6/5/2025).

United States 118th Congress (S=Senate, HR=House of Representatives) For reference

- [S.626/H.R. 1637: Comprehensive Care for Alzheimer's Act](#). Recommend that the Center for Medicare and Medicaid Innovation test the effect of a dementia care management model. Under the model, participating health care providers receive payment under Medicare for comprehensive care management services that are provided to individuals with diagnosed dementia, excluding Medicare Advantage enrollees, hospice care recipients, and nursing home residents. Required services include medication management, care coordination, and health, financial, and environmental monitoring, as well as trainings and other support services for unpaid caregivers. Providers must furnish services through interdisciplinary teams and must ensure access to a team member or primary care provider 24-7. The CMMI must set payments and determine quality measures for the model in accordance with specified requirements. The bill also allows the CMMI to design a similar model under Medicaid. S: Read twice and referred to Committee on Finance (3/2/23) HR: Referred to Subcommittee on Health (3/24/23)
- [S.134/H.R. 620: Alzheimer's Accountability and Investment Act](#). This bill requires the National Institutes of Health to annually submit, beginning in FY2024, an estimate of its budget and personnel needs for carrying out initiatives pursuant to the National Alzheimer's Project directly to the President for review and transmittal to Congress. The Department of Health and Human Services and the Advisory Council on Alzheimer's Research, Care, and Services may comment on the budget estimate but may not change it. S: Passed Senate unanimously (7/30/24). HR: Passed House (9/23/24). 10/01/24 Became law.

- [S.3775/H.R.7218 BOLD Infrastructure for Alzheimer's Reauthorization Act of 2024](#). To reauthorize the BOLD Infrastructure for Alzheimer's Act within the Public Health Service Act. S: Placed on Legislative Calendar (6/18/24). HR: Placed on the Union Calendar (5/21/24). 11/21/24 Passed Senate.
- [S.3981/H.R.7268 DeOndra Dixon INCLUDE Project Act of 2024](#). The bill provides statutory authority for the NIH's Investigation of Co-occurring Conditions Across the Lifespan to Understand Down Syndrome Project (known as the INCLUDE Project). The project was initially established in 2018 to
